## **DRAINAGE REVIEW PERMIT CULVERT/DRIVEWAY MITIGATION GUIDANCE & INFORMATION**

- Allowance for surface drainage must be made at locations identified by the inspector. The nature of such allowance (ie Culvert, Bridge, surface cut, etc.) is a matter for the home owner to decide in consultation with a Professional Engineer (P.E.).
- A report from a P.E., identifying the exact location of all crossings, and the size and type of material to be used, or cross-section to be constructed, must be provided to the SWCD prior to final approval being granted. For properties where a culvert or bridge crossing exists prior to the Drainage Review permit application being filed, the SWCD will still require the same report from a P.E. certifying that the existing crossing meets their approval, or specifying any new design.
- The SWCD does not have any requirements as to the design of the crossing. The P.E. should use their best judgement as to the nature of the site, and the potential liabilities involved. The SWCD will accept the P.E.'s stamp and signature as sufficient to satisfy the requirements of the Drainage Review permit application.
- The homeowner and builder should be mindful of other areas where surface drainage may be crossing a drive location in more of a "sheet" rather than concentrated type of flow. The driveway grade and construction must allow for this flow to continue. Any instances where the driveway grade is preventing the flow of water from continuing in its natural course must be mitigated immediately so as not to cause damages to adjoining lands.
- A final inspection will not be performed until all heavy construction traffic has been completed for the site. Please notify the SWCD the area is ready for final inspection at least two working days in advance. The SWCD inspector will verify that all crossings have been installed and maintained per the P.E.'s report, and that no other areas of the driveway appear to be blocking surface drainage patterns.
