To the Board of County Commissioners of Delaware County, Ohio:

The undersigned hereby petition your honorable body to order the drainage improvement described herein (the "Improvement") and states as follows:

- 1. The Improvement consists of the following nature of work, as set forth in R.C. 6131.04(B)(1): To generally improve the drainage, both surface and subsurface, to a good and sufficient outlet by replacing, repairing, or altering the existing improvements as required and/or creating new surface and subsurface drainage mains or laterals, and to maintain these improvements per the associated engineering drawings as requested by this petition.
2. The course and termini of the Improvement, including the branches, spurs, or laterals, if any, are as follows: In Delaware County, Genoa Township, within the Williams-Miller-Holmes #2 watershed and generally following, but not limited to, the course and termini of the existing improvements inclusive of the existing flood control improvements within the Village at Harvest Wind condominiums. We also request the Board of Commissioners consider consolidation of the petition with the Lanetta Lane Drainage Improvement Petition per the provisions of the Ohio Revised Code Sec 6131.13
3. The construction of the Improvement is necessary and will benefit the petitioner(s).
4. All costs of engineering, construction, and future maintenance will be assessed to the benefiting parcels of land, except as ordered under an appeal filed in accordance with R.C. 6131.31.

5. A list of the names and addresses, where known, of all the owners of the land that the petitioner(s) or the county engineer claims will be benefited or damaged by the construction of the Improvement, as determined by the county engineer, is attached hereto.
6. Prior to filing this petition, the petitioner(s) consulted with the county engineer to discuss the Improvement and to determine the proper forms and procedures for filing the petition.
7. This petition is accompanied by a bond, in the sum required in R.C. 6131.06(A) and on the conditions required in R.C. 6131.06(B).

Please see the attachments for the petition and bond forms as well as our suggested language for the petition. You are free to use whatever language you like for the petition, but we have found this language to work very well for us over the years. Please note the petition and fillable section of the bond form must be completed digitally and then printed. The Commissioners office does not accept handwritten petitions. I have also attached a list of the benefitted parcels which you will need to print and attach to the petition. One thing that completely did not even think about last night concerns the bond. The law requires the bond to be \$1500 plus \$5 for every parcel in excess of 200. There are 331 parcels in the watershed, so the required bond will be \$2,155. Sorry about that, it just didn't even enter my head last night when we were discussing it. The bond is still returned in full though if the Commissioners approve the petition at the first hearing.

When you have everything completed and are ready to file the petition, please contact the Clerks office to schedule a time to file the petition. I have attached Jennifer Walraven and Sarah Dinovo to this email, and they can also be reached at 740-833-2108 and 740-833-2105 respectively.
