To the Board of County Commissioners of Delaware County, Ohio:

The undersigned hereby petition your honorable body to order the drainage improvement described herein (the "Improvement") and states as follows:

1. The Improvement consists of the following nature of work, as set forth in R.C. 6131.04(B)(1):

To generally improve the drainage, both surface and subsurface, to a good and sufficient outlet, by replacing, repairing, or altering the existing improvements as required and/or creating new surface and subsurface drainage mains or laterals, as requested, by this petition, and to maintain these improvements.

2. The course and termini of the Improvement, including the branches, spurs, or laterals, if any, are as follows:

In Delaware County, Liberty Township, within Section 2 Part 2 of the Big Bear Farms subdivision and generally following, but not limited to, the course and termini of the existing improvements. This specifically includes, but is not limited to, the retention ponds located within Big Bear Farms subdivision, immediately south of Seldom Seen Road.

- 3. The construction of the Improvement is necessary and will benefit the petitioner(s).
- 4. All costs of engineering, construction, and future maintenance will be assessed to the benefiting parcels of land, except as ordered under an appeal filed in accordance with R.C. 6131.31.

Delaware County Drainage Improvement Petition Bond

KNOW ALL PERSONS BY THESE PRESENTS, That we, principal, and BBF HOA CHEEK, as surety, are held and firmly bound unto Delaware County, Ohio, in the sum of 1 500.0 Dollars, to the payment of which sum, well and truly to be made, we do hereby jointly and severally bind ourselves, our heirs, executors and administrators. Signed by us and dated at Delaware, Ohio, this 215T day of Movember, 2023. THIS CONDITION OF THE ABOVE OBLIGATION IS SUCH, That, Whereas, on the 213T Day of Movember, 2023, a petition was filed with the Clerk of the County Commissioners of Delaware County, Ohio, by James Demsky 1 BBF HoA, and others, making
application to the County Commissioners for a drainage improvement generally described as follows:
In Delaware County, Liberty Township, within Section 2 Part 2 of the Big Bear Farms subdivision and generally following, but not limited to, the course and termini of the existing improvements. This specifically includes, but is not limited to, the retention ponds located within Big Bear Farms subdivision, immediately south of Seldom Seen Road.
Now, if the said principal will pay all costs associated in preparing for the view and first hearing if the petition is not granted or if the petition is for any cause dismissed, then this obligation shall be void; otherwise it shall be and remain in full force and virtue in law.
The above bond is approved this

One Thousand Five Hundred Dollars (\$1,500.00), plus the sum of Five Dollars (\$5.00) for each parcel of land in excess of two hundred parcels that are listed in the petition as lands that will benefit from the improvement
